CREED

Contest Description

Contestants are to recite, from memory, the SkillsUSA Creed and answer questions about the meaning and importance of its components.

Eligibility

Open to active SkillsUSA California middle school and high school members enrolled in their first year of a career or technical program with entry-level job skills as the occupational objective. A letter from the appropriate school official on school letterhead stating the contestant is classified under the provisions of Public Law 105-17, Individuals with Disabilities Education Act, 1997, is required for participation.

Clothing Requirements

All contestants are required to be in the SkillsUSA Official Attire: Class A Clothing Classifications

Class A SkillsUSA Formal Attire for Men:

- Red SkillsUSA blazer, windbreaker, or sweater
- White dress shirt
- Plain solid black tie
- Black dress slacks
- Black dress shoes

Class A SkillsUSA Formal Attire Official Attire for Women:

- Red SkillsUSA blazer, windbreaker, or sweater
- White collarless or small-collared blouse or white turtleneck (Collar must not extend over the blazer lapel or the sweater or windbreaker)
- Black dress skirt (knee-length) or black dress slacks
- Black shoes



SCOPE OF CONTEST

1. Recitation

- a. Contestants should prepare for the SkillsUSA Creed recitation by developing the following competencies:
 - i. Demonstrate good grooming in dress and personal hygiene
 - ii. Demonstrate an effective and pleasing delivery style
 - iii. Pronounce words in a clear and understandable manner
 - iv. Demonstrate good platform deportment and personal confidence
 - v. Effectively vary voice in pitch, tone, tempo, and volume.
- b. The topic for the recitation is the official SkillsUSA Creed (Long Version) as published in the most current SkillsUSA Leadership Handbook https://www.skillsusa.org/about/history-brand-resources/creed/
- c. The contestant may not use a manuscript, note cards or any other written material.
- d. No introductory or concluding remarks to the SkillsUSA Creed will be allowed other than the title and author.
- e. One judge will serve as a prompter to assist students who falter (10 seconds) during a recitation.
- f. Contestants will not mention their name, school, city, or state.

Observers

- Observers will be permitted to hear the speeches in the presentation room provided that space is available.

SkillsUSA CREED INTERVIEW QUESTIONS

Following the student's recitation of the Creed, the exact same questions must be asked of each contestant. in the same order.

One question per judge (minimum: 1 question). Contestants have a maximum of 3 minutes to respond to all questions.

Sample Questions:

- 1. Which part of the creed means the most to you and why?
- 2. Describe a time when you set an example for others
- 3. How do you plan to further your education to be a better worker in your chosen occupation?
- 4. Tell me/us about a time when you had to go above and beyond the call of duty to get a task done.
